Action/Discussion Items

1) Approval of Minutes from the November meeting - (No December meeting).

Motion was made by Gary Briers, Seconded by Scott Cummings to "Approve the November minutes as distributed." Motion passed unanimously.

2) Graduate Student Funding for Fall 2012 – Tim Murphy

Open discussion. Dr. Murphy provided information again regarding GA funding (changes to tuition payment). OGS stopped funding Masters Students last year, the College has said they will stop Summer 2012. The goal for Departmental resources is to provide competitive packages for highly-qualified students. Options the Department could take, 1) do nothing, leave offers the same, follow the College, Ph.D. Assistants have tuition support, Masters Assistants do not; 2) Change offers for Masters Students to recognize the loss of tuition support. If we change MS offers, we can A) reduce the total number of GAs in the Department; or B) reduce the amount of support for GAs. The other important questions are; should all offers to Departmentally-funded GAs remain equal, or vary based on qualifications, and should we continue to build in automatic annual raises during their Assistantship?

He would like to receive feedback from everyone ASAP. The Fall 2012 offer letters will go out soon.

Dr. Elliot stressed that any proposed increases in graduate stipend should not be described as funding tuition. Direct all questions regarding Assistantship Funding to Dr. Murphy.

3) Summer and Fall Class Schedules – (Drafts – Attachment A, B) – Tim Murphy

Fall 2012 - ALEC 681 Seminar is still listed as staff, however it was determined it would be taught by an AGSC faculty member. Dr. Harlin volunteered to teach, however, she could not at the 10:20-11:10 time period. She will meet with the group and determine a decision.

Both schedules have been submitted to the Registrar. We will be asked for updates soon and changes can be made to that draft.

- 4) Graduate Curriculum Committee Report Gary Briers
 - a. Faculty "Stewardship" of Course Rotation **No changes at this time**. This item has been moved below as part of an appendices section which will be provided each month.
 - 1. International Ag Course Rotation Manuel Pina

Dr. Pina has sent out information to all faculty asking about feedback on the international course descriptions/rotation. Some suggestions have been received. He feels that it would benefit this research if faculty that teach the international courses would share their syllabi to all. He plans to continue meetings and conversation and is open to all suggestions.

5) Schedule of Graduate Admissions Review meeting- February 1 Deadline

Open discussion about current fellowship/scholarship deadlines. They occur early in the Spring semester usually before February 15. These are highly competitive and meeting our February 1 deadline, we may be missing those applicants. It was suggested not to change the deadline, however, to inform students interested in applying for these opportunities to apply earlier, perhaps by January 1. It was suggested to change web page and prospective handouts. (This has been done).

It was agreed to place the February cycle Admission Review on the regular scheduled February Graduate Faculty meeting agenda.

Old Business

1) Five year course rotation – **No changes at this time.** This item has been moved below as part of an appendices section which will be provided each month.

New Business

1) Dr. Strong indicated that he has taught ALEC 695 online every semester since he started. It was determined in previous meetings that ALEC 695 online would have different faculty teaching it on a rotation. Dr. Odom volunteered to teach the course Spring 2013.

Informational Items

1) Relevance of online graduate courses for on-campus students – Gary Wingenbach

Dr. Wingenbach was not present. Dr. Murphy conveyed Dr. Wingenbach's concerns. He is concerned that only offering some courses as online courses or Study Abroad and not campus sections too, that students are lacking the residency and opportunities to visit with faculty. It is suggested to offer campus sections of online/study abroad courses too. From this conversation -- Dr. Strong volunteered to teach ALEC 640 as a campus section Fall 2012. It has been placed on the schedule.

2) Invitation to attend beginning of GPC meeting (Feb.15) – Informational session about inviting and hosting international faculty and graduate students – Tim Murphy

I am delighted to announce an invitation to submit nominations for the U.S. Senator Phil Gramm Doctoral Fellowships. This fellowship, available only to currently enrolled doctoral students at Texas A&M University, recognizes scholarly excellence. The Gramm Fellowship was established to promote, encourage and reward outstanding teaching and research by doctoral students whose command of their respective disciplines exemplifies the meaning of scholar/mentor in the highest sense.

In 2000, an endowment was created by the Texas A&M Foundation from donations given in honor of Dr. Phil Gramm, former U.S. Senator and Texas A&M University Economics Professor. This endowment reached maturity, allowing the Office of Graduate Studies to begin making awards in 2007.

This spring, 5-10 students will be recognized as Gramm Fellows and receive fellowships of \$5,000 each. I encourage you to nominate the doctoral students in your department who are outstanding scholars for this award.

Please note that award nominations must be routed through the Colleges. Departments must submit their nominations to their respective College by March 12. Colleges must submit their nominations to the Associate Provost for Graduate Studies by March 16. Interdisciplinary PhD programs should send their nominations directly to OGS by March 16, 2012.

U.S. Senator Phil Gramm Doctoral Fellowships

Nominee Eligibility

- 1. The nominee must, at the time of nomination and receipt of award, be an enrolled doctoral student in good standing with the University with a cumulative GPR of 3.0 or better.
- 2. The student's approved dissertation research proposal should be on file in the Office of Graduate Studies.
- 3. The nominee must have taught on at least a one-half time basis for two semesters or summer sessions (10 weeks) during his or her doctoral enrollment at Texas A&M University, or must be completing the second semester of teaching at the time of nomination for the award.
- 4. The nominee must have had independent authority to assign grades for course work or laboratory sections taught.
- 5. The student should have completed a substantial portion of his/her research at the time of nomination, and the research should be considered of the highest quality for the nominee's field of study and demonstrate an outstanding command of the discipline.
- 6. The nominee should represent excellence in college-level teaching and research; have outstanding scientific, mentoring and pedagogical skills; and have a reputation for ethical behavior in all aspects of scholarly life.
- 7. Previous nominees may be nominated again but no prior awardees may be re-nominated.
- 8. The nominee must not be a full-time member of the Texas A&M University faculty or staff at the time of nomination.

Submission Procedure

- 1. Departments are invited to submit nominations to their college graduate dean by March 12. Interdisciplinary programs should submit their nominations directly to the Associate Provost for Graduate Studies by March 16. Each nomination packet should include the following information:
 - A. A cover sheet (first page of the nomination packet) that includes:
 - Title stating: Nomination for Gramm Doctoral Fellowship
 - Full name of student, student's email, and student's current address
 - Name of nominator, relationship to student, department, and nominator's email
 - B. A letter of nomination, summarizing the student's qualifications and why this student should be selected for the award (2 pages maximum).
 - C. **Personal, academic and career information** about the nominee, such as a curriculum vitae or resume.
 - D. Letters of support regarding the nominee's teaching and research abilities by the faculty members of the nominating department, peers of the nominee, and students previously taught by the nominee at Texas A&M University. No more than two letters of evaluation in each of the categories should be submitted.

- E. The student's specific research, teaching and scholastic achievements. This information can be provided as part of the letter of nomination or as a separate list, and should include some or all of the following.
 - Information in support of the nominee's teaching abilities, including, but not limited to, courses taught, number of students enrolled, type of preparation required for teaching courses, course evaluations, and grade distributions.
 - Academic awards, scholarships, fellowships, or other scholarly recognition since becoming a graduate student.
 - Presentations at local, state, national, or international meetings of professional societies or topical conferences. (Identify meeting or conference, title of presentation, place, date, and role played by student).
 - Printed or submitted publications. List a complete bibliographic citation with authors in the published order.
 - Other research-related, scholarly, creative or innovative activities (techniques, devices, or concepts developed; major performances, exhibits; grant proposals written; etc).
 - Please do not include manuscripts.
- 2. Each college and IDP will review nominations, selecting the top two students and forwarding these two nominations in one PDF file to the Office of Graduate Studies by March 16 for the final selection of Gramm Fellows. The top two nominations should be scanned and emailed in ONE PDF FILE to Megan Palsa at meganp@tamu.edu

A selection committee of graduate faculty will evaluate and choose the recipients of the Gramm Fellowship. Announcements of the 2012 Gramm Fellows will be made in March. Fellowship recipients will be recognized and receive their awards at a ceremony on Wednesday, April 11 in the University Club on the 11th floor of Rudder Tower at 4 p.m.

Distinguished Graduate Student Award for Excellence in Research

Eligibility Criteria

- 1. Eligible students include those who graduated in Augustor December of 2011 and those who are scheduled to graduate no later than May of 2012. Students who graduated prior to the August 2011 commencement are not eligible.
- 2. Currently enrolled student nominees must have a cumulative GPR of 3.0 or better.
- 3. Previous nominees may be nominated again but no prior awardees may be re-nominated.
- 4. The student's approved research proposal must be on file in the Office of Graduate Studies at the time of nomination.

Required Information to be Submitted by the Nominating Department

- 1. A cover sheet (first page of the nomination packet) that includes:
 - a. Title stating: Nomination for Excellence in Research (indicate Master's or Doctoral)
 - b. Full name of student, student's email, and student's current address
 - c. Name of nominator, relationship to student, department, and nominator's email
- 2. A letter of nomination, summarizing the student's qualifications and why this student should be selected for the award.
- 3. A listing of he student's specific research and scholastic achievements. This information can be provided as part of the letter of nomination or as a separate list. Please do not submit copies of theses, dissertations, or manuscripts.
 - a. Academic awards, scholarships, fellowships, or other scholarly recognition since becoming a graduate student.
 - b. Presentations at local, state, national, or international meeting of professional societies or topical conference. Iidentify name of meeting or conference, title of presentation, place, date, and role played by student).
 - c. Peer-reviewed publications. Document those accepted but not yet published. List a complete bibliographic citation with authors in the published order.
 - d. Other publications (books, book chapters, conference proceedings, abstracts, etc.).
 - e. Submitted publications or abstracts Other research-related, scholarly, creative or innovative activities (techniques, devices, or concepts developed; major performances or exhibits; grant proposals written, etc).
- 4. Letter of support/recommendation from faculty or colleagues (limit to three) who can attest to research quality and productivity.
- 5. A "layman's summary" written by the student nominee of his/her research program, its scientific or scholarly significance, and the relationship to his/her career goals (limit to two pages, double spaced; use separate sheets). Translating research into terms understood by the public is difficult for most students to do, but an important task for all to learn. Faculty are requested to refrain from editing. Append the thesis or dissertation abstract, if available.

Distinguished Graduate Student Award for Excellence in Teaching

Eligibility Criteria

- 1. The nominee must, at the time of nomination, be enrolled for a minimum of nine hours of course work.
- 2. The nominee must have a cumulative grade point average of 3.0 or higher.
- 3. Previous nominees may be nominated again but no prior awardees may be re-nominated.
- 4. Persons who have had more than five years of **full-time**, **professional teaching experience** are excluded from the competition.
- 5. The nominee must have taught on at least a one-half time basis for two semesters or summer sessions (10 weeks) during his or her graduate enrollment at Texas A&M University; the nominee may be completing the second semester of teaching at the time of nomination for the award.
- 6. At the time of teaching the courses in item 5, the nominee must have been classified as a Graduate Assistant or as a one-half time lecturer/instructor with teaching responsibilities.
- 7. The nominee must not be a full-time member of the Texas A&M University faculty or staff at the time of nomination for the award.
- 8. The nominee must have had independent authority to assign grades for course work or laboratory sections taught.

Required Information to be Submitted by the Nominating Department

- 1. A cover sheet (first page of the nomination packet) that includes:
 - a. Title stating: Nomination for Excellence in Teaching
 - b. Full name of student, student's email, and student's current address
 - c. Name of nominator, relationship to student, department, and nominator's email
- 2. A letter of nomination, summarizing the student's qualifications and why this student should be selected for the award.
- 3. Personal information about the nominee, such as an academic curriculum vitae.
- 4. Evaluations of the nominee's teaching by the faculty members of the nominating department, peers of the nominee, and students previously taught by the nominee at Texas A&M University. No more than two letters of evaluation in each of the proceeding categories should be submitted.
- 5. Information about grade distributions for each class taught by the nominee.
- 6. Information about courses taught, number of students enrolled, and type of preparation required for teaching courses.
