Lecturer position update – Dr. Elbert

They like our overall plan but wanted us to pursue a partnership with Extension and/or Research. • Post-Tenure Review – Dr. Briers

Only tenured faculty. Current process is over ten years old. The new plan uses , at a minimum, three designations, Unsatisfactory, Needs Improvement, and Satisfactory. We currently use Unsatisfactory, Satisfactory, Meritorious, and Most Meritorious. Time table is no less than every six years. Dr. Briers asked faculty to compare DOF documents to our document and see where you believe we are. Dr. Briers will bring an updated draft document to the next meeting. A vote will be taken in the future.

Merit and APR Review – Dr. Elliot

Drs. Boyd, Elbert, and Harlin volunteered to serve on a committee to review departmental merit and APR plans. They will meet as soon as possible and will review the entire process including the score card.
